The fact is over half of Americans who pass away each year do not have valid wills. Most people don't realize how important a will is and some don't think they own enough property to need one. Unfortunately, those people's estates are left for the state to distribute, often running up large fees that are taken out of the estate and leaving less to their loved ones.

Well-thought-out wills combined with other estate planning tools can help make your estate plan more effective. Some of the facts that are important to know about wills are:

- If you do not have a will, state law determines who gets what in your estate. This is an impersonal way to distribute your assets. The state doesn't consider your wishes and they don't make exceptions. They may also deplete your estate with certain fees and other expenses. Especially with smaller estates, it is important for things to be settled quickly since delays usually mean increased expenses.
- A well planned will can make a number of provisions that can reduce estate taxes. Also, a husband or wife may leave all property to his or her spouse and pay no federal estate taxes on the estate of the first to die.

A well planned will allows you to take advantage of this marital deduction and eliminate taxes in this manner.

- Both husband and wife should have a will, even if the two wills would be made up essentially the same. They should compliment each other and take into account any special bequests to other family members. Even if you have joint ownership of items, it may create unnecessary estate taxes and result in the imposition of gift taxes.
- Writing your own will is generally not advisable. Many homemade wills are declared invalid by the courts. Professional expertise in putting together your will is a must.

Another thing to consider is tithing your estate. So many of us tithe throughout our lifetimes, why not tithe the remainder of God's gifts to us in our will. What a testimony and what a wonderful way to further God's work in Mississippi and abroad.

Overview of each investment fund

MBF Equity Fund, a growth stock fund, is designed for capital appreciation with little emphasis on income. Five outside professional money managers invests the fund in stock offerings of U.S. and international corporations.

MBF fixed Income Fund, a bond fund, is designed to provide income, with little attention given to capital appreciation. Two outside professional money managers invests the Fund in U.S. government securities and corporate bonds.

MBF General Endowment Fund is designed to meet the long-term investment objectives of perpetual endowment accounts. The Endowment Fund seeks to provide income while guarding against the effects of inflation. The current allocation of the Endowment Fund is 30% in the MBF Equity Fund and 70% in the MBF Fixed Income Fund.

MBF Short Term Cash Fund, an enhanced money market fund, is designed to out-perform the current yields from six to twelve month certificate of deposits, as well as the 91-day Treasury bill rate. The Short-Term Cash fund matches a competitive rate of return with full liquidity. One outside professional money manager manages the Fund.

For over 50 years, Mississippi Baptist churches and institutions and their members have trusted the growth of their funds to the Foundation.

- Your full name and social security number
- Address and phone number
- Spouse's full name and social security number
- Full name and relationship of each person who will receive anything under your Will and is to be included in your Estate plans
- Full name, address, and phone number of Personal Representative (Executor/Executrix)
- Full name, address, and phone number of Guardian of Minor Children
- List any property to be distributed: (Securities, Real Estate, Life Insurance, Retirement plans, Personal possessions)
- List specific bequests. Match people with property. (Specific amounts of money or specific items of property)
- List who will receive the balance of your estate and the percentage each is to receive
- Decide what you want to happen if the individual you listed to receive property or the individual who is to be your personal representative predeceases you
